Welcome to Anointed Works's official website!

Thank you for visiting our website and other social media platforms we are a part of. Please read our TOS (Terms Of Service) carefully before creating an account on our website or applying for our services. Your access to follow us on social media platforms, your right to browse our website and partake in services is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, members and any third party who has access to our outlets or business partners. By joining our website and creating an account with us, you give consent to be bound by these Terms until you request to have your account deleted. If you disagree with anything you read then you shall not create an account on the website or be showcased as a creator on our website.

Affiliates: AW does not claim or share with affiliates for profit gain, we do so for free. Currently our affiliates are a small team of Christian creators.

1. Acceptance Of Terms

1.1 Responsibility

By engaging with our website, following us on platforms or anything that contain links to this agreement, you agree to be legally bound by the Terms and Conditions stated in this policy. Terms may be subject to amendment, additional guidelines or rules and all additional Terms, guidelines and rules that are incorporated by reference into this agreement.

2. Requirements To Use Services

2.1 Age Requirements

We offer (4) types of services, but you must be of a certain age to apply for them. By default, you are required to be at (15) years old or older to make an account on the website.

Service 1: To be exposed to our Christian projects or our blog posts, videos, etc. you must be (15) years or older in the United States Of America.

Service 2: If you are under the age of (15) years old in the United States Of America, you have permission to use the Service for account creation, but you do not have permission to enroll at Unaligned Academy® (UA) and receive Christian education, you cannot be a sponsored until you (18) years or older. You may read the Blog where we discuss Christian education and our projects, but you must have permission from parent(s) or a legal guardian(s) to do this.

Service 3: If you are under the age of (18) years or older in the United States Of America, you have permission to use the Service for account creation, you may enroll at Unaligned Academy® (UA) and receive Christian education and may be a sponsored. You may engage with our Christian projects, read blog posts, watch videos, etc. and do not need permission from parent(s) or a legal guardian(s).

Foreigner Disclaimer: If you are a foreigner, it is your responsibility to know the appropriate age in your country to be exposed to Christianity and Christian education. Until you are the legal age in your country, foreigners are not allowed to create an an account on the website, engage with projects or enroll at UA. Foreigners who lie about their age will be reprimanded and their accounts will be deleted and they will be banned from our website. AW and UA are not liable for this and does not claim responsibility of exposing Christianity to a minor in another country who intentionally lies about their age and creates an account to access our services. To whomever it may concern, we take this part of our policy very seriously and do not tolerate foreign minors who do not have permission to be taught or exposed Christian education in their country. This is a criminal offense and we will not allow deception. Should this happen, we will act and persecute the offender respectfully to the full extent of the law of the nation our Corporation resides in.

Service 4: If you are (18) years or older in the United States Of America, you have permission to use the Service for account creation, you may be exposed to our Christian projects, our blog posts, videos, etc., purchase VIP subscription and do not need permission from parent(s) or a legal guardian(s). If you are a minor under the age of (18), you must have permission from your parent(s) or legal guardian(s) to purchase VIP subscription.

2.2 Website Content & Doctrine

There is Biblical information all over this website. It's in our blog posts, our notes, our projects, headlines, subject lines, etc. There are Godly topics and Christian anime illustrations and images posted on the website intended for older mindsets. We uphold the law of Yahweh and everything the Book states. We are not like most groups as we do not have a religion we swear by. AW simply follows Yahweh and does what the Book says without putting our human views, feelings, opinions, theories etc. into what we do as professionals. Our Chirstian creators who we sponsor also have links and bios that point to Christianity. We endorse the entire Book and the original 200 books at Unaligned Academy® (UA). If such content and doctrine offend you, you do not have permission to create an account or enroll at UA.

2.2 Social Media

When someone follows us on social medias we will never ask that person their age, sex, or location. We will never tell them our age, sex, or location either. Any information parents/legal guardians need they can find on our website and other platforms we are a part, such as LinkedIn, Instagram and X. Our <u>Team</u> page has all the information we provide to the public unless a situation requires us to give out more information, but in most cases, we do not need to do that and our followers shouldn't expect us to do that.

We can't stop people of younger ages from following us directly because many platforms allow anyone to simply click and follow. What we can do is limit who we engage with publicly and privately. By reading our <u>Social Media Policy</u> you acknowledge the warnings we give you, the risks involved if you disregard our warnings and accept that AW reserves the legal right to press charges against minors who try to trap us and accuse us of doing inappropriate conduct. When speaking to minors, we do so publicly on feeds or walls.

All calls made to the organization and any emails or text messages on platforms are archived for training and protection purposes.

2.4 Copyrights & Fanworks

All projects, illustrations, digital illustrations created by our devs are © Copyright of AW, our affiliates. All rights reserved. We will not tolerate theft. If AW and or an affiliate of AW find our content uploaded on other sites by fans or third-party websites without our permission, we reserve the right to press charges and have legal documentation stating we can do so. We strongly advise people to not download artwork or stories through third parties.

If a fan is doing a review, podcast commentary about our projects or our business partner's projects in a YouTube documentary or commentary, then he/she can post the original artwork they find on Google or via social media. This is not an act of theft and anyone can do take copies of the artwork or request to use copies of the artwork and will be protected by "Fair Use". 3. Termination

3.1 Account Deletion

We may terminate, suspend or block your access to our website or social media immediately with or without prior notice if you breach the Terms Of Service and the policies stated in this agreement.

4. User Content

4.1 Your Rights

Our Service allows you to post comments on the website, provide feedback to staff and grant badges privileges that enables you to grow in the community.
