We do not permit children to create accounts with our Service this website is bound by the FTC's

COOPA Act. AW does not harvest, collect, data, personal information of people to sell to others.

What data we do collect and what cookies we use are simple, common and needed in order to

better serve our community. Privacy is taken very strictly here. Your account and billing

information will not be shared with third-parties at any time. Our Privacy Policy explains what

cookies we use and what data is collected by AW. None of this data is for sale and no one will

receive subscriptions, newsletters, or marketing mail to their inboxes.

In the Privacy Policy is has stated that we do (as a default) but have no need for those things here.

If we decide in the future to use marketing emails to raise money or then that section of the

Privacy Policy will apply. For those who are not familiar with COOPA, COOPA imposes certain

requirements on operators of websites or online services directed to children under (13) years of

age and on operators of other websites or online services that have actual knowledge that they are

collecting personal information online from a child under (13) years of age. This is not to be

confused h the defunct Child Online Protection Act, abbreviated "COPA".

The Child Online Protection Act was a law in the United States of America, passed in 1998 with the declared purpose of restricting access by minors to any material defined as harmful to children on the internet. This law never took effect, as three separate rounds of litigation led to a permanent injunction against the law in 2009. The law was part of a series of efforts by US lawmakers legislating over internet pornography. Parts of the earlier and much broader Communications Decency Act had been struck down as unconstitutional by the Supreme Court in 1997 and COPA was a direct response to that decision, narrowing the range of material covered. COPA only limits commercial speech, and only affects providers based within the United States. COPA required all commercial distributors of "material harmful to minors" to restrict their sites from access by minors. "Material harmful to minors" was defined as material that by "contemporary community standards" was judged to appeal to the "prurient interest" and that showed sexual acts or nudity (including female breasts).

This is a much broader standard than obscenity at AW. Although we will not show harmful on our website to the public, we are not in support of what the world deems as "okay" for minors in many cases. Showing nudity or partial nudity, demonic images, bad/suggestive language, indoctrination of LGBTQ+ lifestyles that is clearly advertised in ads, ads for app games, themes in online games (for children) and hidden political messages in cartoons, anime, comics etc. is socially acceptable to show to children in our modern age, but it inappropriate and demonic by Yahweh's standards. Minors over the age of (15) will be exposed to our content, that is Godly, but never to ads, promotions, offers, email campaigns with images or video links that support these socially acceptable themes.

We do endorse what has been done with the law of COOPA. The Children's Online Privacy Protection Act of 1998 (COPPA) is a United States federal law, located at 15 U.S.C. §§ 6501–6506 (Pub.L. 105–277, 112 Stat. 2681-728, enacted October 21, 1998. The act, effective April 21, 2000, applies to the online collection of personal information by persons or entities under U.S. jurisdiction about children under 13 years of age including children outside the U.S., if the company is U.S.-based. It details what a website operator must include in a privacy policy, when and how to seek verifiable consent from a parent or guardian and what responsibilities an operator has to protect children's privacy and safety online including restrictions on the marketing of those

under (13). While children under (13) can legally give out personal information with their parents' permission, many websites such as social media sites, but also other sites that collect most personal data, disallow children under (13) from using their services altogether due to the cost, and work involved in complying with the law.

If you are a parent reading this section, please do not allow your child to create an account on our website unless they are (15) years of age or older. By allowing them to have an account with us, we will assume you have read our Terms Of Service and Privacy Policy and have agreed to our conditions and community guidelines pertaining to this topic. If you are merely investigating this policy and do not agree with it, that's fine because you're an adult. It's not fine if your child comes to our website, creates an account as well as enrolls at Unaligned Academy® (UA) and has lied to us about their age and may possibly even have taken your billing information without your knowledge.

Do not break the laws of the land that is placed in this nation our Corporation lives in. These are federal, some even nationwide laws and AW reserves the legal right to press charges if a minor enters our site and did not read the Terms Of Service. This is especially vital for people who refuse to believe in Yahweh, disagree with Yeshua and the Book's (Bible) doctrine. Such content is on display all throughout the website. UA teaches the dangers of false doctrine and the true faith, not religion, but simply how to test Yahweh and to reveal how He is truly the only Elohim with no rival, equal or other "gods" in existence.

Isaiah 45 and the Book Of Enoch touch on these truths and we have artifacts to prove our faith, but to parents who claim their religion and beliefs is truth, our website is a direct insult to that and minors should not be here talking to our adult staff about these topics without their parents' permission. Visitors of our website should *never* fake their age for any reason. Visitors who are minors, *do not* try to trap our staff with Book questions, enroll at UA and claim you're an adult, then we find out that you are a minor who lied about your age. We reserve the right to press legal charges if a minor attempts to trap us like this. All messages sent in the live chat and emails sent to us are archived for protection purposes and will be used in a law court as evidence if needed, so keep that in mind before lying to our team about who you are and your age.
