ARTICLES OF ORGANIZATION

Articles Of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Corporation under the Corporation Law of Kentucky, do hereby certify:

First: The name of the Corporation shall be ANOTED WORKS L.L.C.

Second: The place in this state where the principal office of the Corporation is to be located is the city of Lost Creek, Breathitt County.

Third: Said Corporation is organized exclusively for religious, educational, free services and scientific purposes.

Fourth: The names and addresses of the persons who are the initial trustees of the Corporation are as follows.

Fifth: No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Sixth: Upon the dissolution of the Corporation, all personal assets that were supplied for company purposes shall be fairly divide between the Trustees in private and will not be settled in court unless Trustees come together and agree to proceed with court procedures.
